*Proper references must be inserted inside the article like 1, 2, 3.... and relevant references must be given at the end of the article Minimum five references are essential.

*References must be listed alphabetically or sequentially in the following order - Surname, Name, Year in Bracket, Name of the Book/Journal, Details of Publisher, Place and Page number at the end of the research paper. *Research Article should be written in minimum 1500 and maximum 3000 words
