\*Paper should be sent in two hard copies along with CD or by E-mail: editornavjyot@gmail.com

\*Authors are solely responsible for the factual accuracy of their contribution.

\*Proper references must be inserted inside the article like 1, 2, 3.... and relevant references must be given at the end of the article Minimum five references are essential.

\*References must be listed alphabetically or sequentially in the following order - Surname, Name, Year in Bracket, Name of the Book/Journal, Details of Publisher, Place and Page number at the end of the research paper. For ex. Dilli K. T. (2009) Library and Information Science in Digital Era, Atlantic Publishers, New Delhi, P.153.

\*Authors are requested to submit diagrams, maps and pictures of their writings in a separate file with jpg/gif extension.

\*Research Article should be written in minimum 1500 and maximum 3000 words
